Dear Masters' Fans:

Thank you for inquiring with Hampton Inn Augusta concerning overnight accommodations during the 2012 Masters Golf Tournament where you will be sleeping on Cloud 9! Our rate includes Hampton "On the House" Hot Breakfast Bar, shuttle service to and from Augusta National, a Pool side Evening Reception (buffet dinner with beer and wine) and a daily newspaper for full coverage of the Masters. In 2012, we will be offering the following packages during the Masters:

Package #1

Sunday, April 1st through Tuesday, April 3rd (departing Wednesday, April 4th) will be available for a minimum three (3) night stay.

Option A: 1 Full Bed (sleeps 2) for a total price of \$900 plus tax (13% & \$1.00 per night). (Total with tax: \$1,020.00).

Option B: 1 King Bed (sleeps 2-3) for a total price of \$1,200 plus tax (13% & \$1.00 per night). (Total with tax: \$1,359.00)

Option C: 2 Double Beds or 1 King Bed with Sofabed (sleeps 4) for a total price of \$1,650 plus tax (13% & \$1.00 per night). (Total with tax: \$1,867.50)

Package #2

Wednesday, April 4th through Sunday, April 8th (departing Monday, April 9th) will be available for a minimum five (5) night stay.

Option A: 1 Full Bed (sleeps 2) for a total price of \$1,875 plus tax (13% & \$1.00 per night). (Total with tax: \$2,123.75).

Option B: 1 King Bed (sleeps 2-3) for a total price of \$2,250 plus tax (13% & \$1.00 per night). (Total with tax: \$2,547.50)

Option C: 2 Double Beds or 1 King Bed with Sofabed (sleeps 4) for a total price of \$2,875 plus tax (13% & \$1.00 per night). (Total with tax: \$3,253.75)

Package #3

Sunday, April 1st through Sunday, April 8th (departing Monday, April 9th) will be available for a minimum eight (8) night stay.

Option A: 1 Full Bed (sleeps 2) for a total price of \$2,400 plus tax (13% & \$1.00 per night). (Total with tax: \$2,720.00).

Option B: 1 King Bed (sleeps 2-3) for a total price of \$3,400 plus tax (13% & \$1.00 per night). (Total with tax: \$3,850.00)

Option C: 2 Double Beds or 1 King Bed with Sofabed (sleeps 4) for a total price of \$4,000 plus tax (13% & \$1.00 per night). (Total with tax: \$4,528.00)

Individual Stays

An individual night's stay for the nights of Sunday and Monday only.

Option A: 1 Full Bed (sleeps 2) for a rate of \$300 per night plus tax (13% & \$1.00). (Total with tax: \$340.00)

Option B: 1 King Bed (sleeps 2-3) for a rate of \$425 per night plus tax (13% & \$1.00). (Total with tax: \$481.25)**

**All room types are not available for individual nights and will consist of a prearranged selection only. Only a certain number will be available and are on a first come prepaid basis.

Reservations must be prepaid in full by check, certified funds, or credit card, which are NONREFUNDABLE. Reservation paid by credit card must also enclose the Credit Card Authorization Form along with a copy of both the front and back of the credit card.

Reservations will be held tentatively for 5 days. If payment is not received within that time, reservations will be canceled and the rooms released for resale. Reservations booked after January 1, 2012, must be prepaid within 48 hours. Please fax or email Masters Information Sheet to 706-738-9988, attention Hotel Sales. Once we receive your payment via fax or mail, we will make your reservations definite and send back your confirmation and receipt. Please be sure to fill the Masters Information Sheet out fully with all necessary information. Please enclose a copy of the Master's Information Sheet along with your payment.
